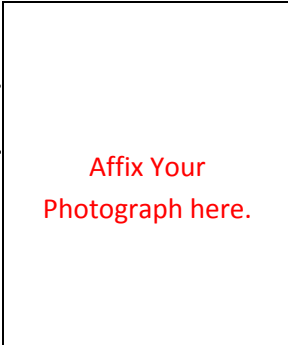

4. Certificate shall be released only after submission of all assignments, performance in the tests and final examination with average 50% marks and 75% attendance. In case of less than 75 % of attendance, admission stands transferred to next batch.
5. Students shall be allowed to appear for the final exam only for 3 attempts. Students failing in the 3rd attempt shall apply for readmission for successful completion of the course.
6. Extra examination fee shall be applicable in case of re-examination.
7. High degree of discipline should be maintained during the period of course, anyone found guilty will be expelled then and there.
8. Admission seats are strictly non-transferable.
